

In March 2025 the "Simpler Recycling" legislation will come into effect in the UK. All businesses with more than 10 employees, schools, hospitals and other non-household premises will be required to separate dry recycling from general waste with the goal of simplifying what can be recycled across different councils in England.

The legislation aims to save resources from going to waste, support the circular economy and enhance sustainability. Businesses will need to have clear signage indicating what materials can be recycled in each waste stream.

Failure to meet these requirements can result in significant fines, with environmental officers conducting routine compliance checks to ensure businesses are adhering to the new regulations.

What waste needs to be separated:

The following materials should be separated for collection, and collected separately:

PAPER & CARDBOARD



GLASS



PLASTIC



FOOD WASTE



METAL

Materials that must be separated include:

Glass: Any type of glass bottles or jars. **Metal:** Aluminium cans and tin cans.

Plastic: Bottles and containers (excluding plastic film).

Paper and Cardboard: Includes all paper types and cardboard packaging.

Food Waste: Proper disposal methods for food waste to minimise landfill contributions.




